A draft of Form 990 is prepared by the Organization's CPA and an electronic copy is forwarded to the Executive Director for review. After any changes requested by the Executive Director are incorporated into the return, a revised electronic copy of the return is forwarded to the entire voting Board. The Board then has an opportunity to comment on the return before it is finalized and filed.

**Form 990, Part VI, Line 12c - Explanation of Monitoring and Enforcement of Conflicts**

Employees are required to sign a Conflict of Interest form every year disclosing any potential conflicts of interest. The Organization's Conflicts of Interest Policy requires Board members to disclose any actual or possible conflicts of interest.

**Form 990, Part VI, Line 15a - Compensation Review & Approval Process - CEO & Top Management**

The Board reviews salaries annually to ensure that BookSpring compensation is in line with similar jobs in similar-size organizations in the greater Austin area.
